Bremen, 29th June 2017: At the 144th Ordinary General Assembly on 28th June 2018, the Board of Directors of the Bremen Cotton Exchange elected **Jens D. Lukaczik** (52) as its new President. Every two years, the cotton world gathers in Bremen: Together with its testing laboratory, the Fibre Institute Bremen (FIBRE), the Bremen Cotton Exchange hosts the International Cotton Conference, which has become the world's leading conference in the field of cotton testing. Around 600 guests from all over the world regularly travel to the Hanseatic city to attend the high-ranking sessions at the Bremen City Hall and take the opportunity to make personal business contacts.
